Dear Dr. LoBasso:

The substantive change, i.e., transfer of sponsorship from Halifax Health Medical Center to Daytona State College for the certificate radiography program was considered at the November 17, 2020 meeting of the Joint Review Committee on Education in Radiologic Technology (JRCERT). The JRCERT is the only agency recognized by the United States Department of Education (USDE) and the Council for Higher Education Accreditation (CHEA) for the accreditation of traditional and distance delivery educational programs in radiography, radiation therapy, magnetic resonance, and medical dosimetry. Specialized accreditation awarded by the JRCERT offers institutions significant value by providing peer evaluation and by assuring the public of quality professional education in the radiologic sciences. The JRCERT took the following action:

## APPROVAL OF SUBSTANTIVE CHANGE.

This substantive change is effective January 2, 2021.

The program is advised that the program total capacity is identified as 30. Any increases in program total capacity must be supported by appropriate human and physical resources and approved by the JRCERT prior to implementation.

The current accreditation status of the program is eight years. An interim report will be required. The projected date for submission of the interim report is the Second Quarter of 2021. The JRCERT will provide program officials adequate notice of the due date for submission of the interim report. Based on the interim report, the JRCERT will determine if the accreditation award of 8 years will be maintained or reduced and the continuing accreditation process expedited.

If the accreditation award is maintained, the next site visit is tentatively scheduled for the Second Quarter of 2025.

The program is also advised that consistent with JRCERT Policy 11.600, the JRCERT reserves the right to conduct unannounced site visits of accredited programs. The sponsoring institution would be responsible for the expenses of any on-site evaluation.

Revised certificates of accreditation and recognition will be mailed to the program director after the effective date.
